- In accordance with the Policy, Organisation and Rules of the Scout Association, the mission of The Malvern Scout District is to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.
- The method of achieving this is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership
- The purpose of the Scout District is to provide leadership, advice and support to 11 Scout Groups (1st, 2nd & 7th Malvern,1st Malvern Link, 1st Malvern Wells, 1st Leigh, 1st Ledbury, 1st Colwall, 1st Cradley, 1st Bosbury, and 1st Upton upon Severn) and 6 District Explorer Scout Units.

 Scout Network and Scout Active Support assist in this effort, especially (in the latter case) by managing the District Camp Site.
- Groups are autonomous and have exciting opportunities for Beaver Scouts (aged 6 8 Years), Cub Scouts (aged 8 10½ Years), Scouts (aged 10½ 14 Years), through the progressive award schemes. Explorer Scouts (aged 14-18 Years) and Scout Network (18-25 Years) continue this development and award system. From 14years of age, youth members can become Young Leaders in the younger age sections.

The Malverns District is just one part of the global Scout Movement which has a youth membership of over 31 million in 216 countries and territories.

- The Districts constitution is published in Chapter 4 of the Policy, Organisation and Rules of the Scout Association, established by Royal Charter granted on 4 January 1912.
- The District is a trust and an educational charity, established under the Scout Associations rules that are common to all Scouts.
- The Trustees (the District Executive Committee) manage the District and generally meet every two months. The District Executive Committee is responsible for complying with legislation applicable to charities, including registration, keeping proper accounts and making returns to the Charity Commission and Scout Association as appropriate.

The District Executive Committee:

Exists to develop and support Scouting in the District and is responsible for:

- Helping Groups and Leaders in meeting their responsibilities
- The maintenance of District property
- The raising of funds and the administration of District finance
- The insurance of persons, property and equipment
- Appointing adult volunteers and assisting in recruitment and training
- Appointing any sub committees that may be required
- Appointing District Administrators and Advisors other than those who are elected
- District Scouting activities and public occasions.

Risk & Internal Controls:

The District has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss; these include 2 signatories for all payments and comprehensive insurance policies to ensure that reasonable risks are covered. The District conducts risk assessments for all activities and provides guidance to Groups and Units on how they should do similarly.

Valuable Contribution by Volunteers:

The District appreciates the generosity, time and effort of a team of talented and committed volunteers and the Baden Powell Guild, all of whom impact directly and indirectly on the District's activities. The District does not employ any paid workers.

Summary of the main achievements of the Charity during the year:

- Continued management and maintenance of Warren Oak District Campsite
- Assisted in recruiting adult volunteer leaders/ assistants
- Vetted with DBS checks, appointed & inducted new volunteers and reviewed and re-vetted some existing volunteers (on a 3 or 5 year system)
- Provided Initial and First Response training and support for volunteers and training for Trustees
- Organised District activities for young members in all five Sections
- Provided financial support for leader training courses

Challenges & Opportunities:

In order to satisfy the demand for Scouting in the District, continuing promotion, recruitment and support of adults as leaders, administrators, trustees, and supporters is needed. There exists the opportunity to open new Sections in existing Groups and to strengthen some Groups and existing Sections.

FINANCIAL REVIEW.

Reserves Policy:

The District's policy on reserves is to hold sufficient resources to continue the charitable activities of the District should income and fundraising activities fall short, and to hold funds to support individuals and Groups in times of urgent need. Trustees consider that the District should hold a sum of £4000 (equivalent to 12 months running costs, excluding subscriptions payable to Headquarters and County) plus £15000 to meet any immediate needs of members, Groups and Units within the District and the District's Campsite at Warren Oak. The District held total reserves of approximately £28000 at the year end.

Investment Policy:

The District does not have sufficient funds to invest in long term investments. The District has therefore adopted a risk averse strategy to the investment of its funds. All funds are held in cash using only mainstream Banks or Building Societies.

DISTRICT COMMISSIONERS REPORT

Firstly, we would like to start with a big **Thank You** to all the leaders and helpers in The Malvern's for everything that they have all done for the Young People in our District during a very difficult time for everyone and we appreciate all of the new and inventive ways that they have adapted the scouting programme to virtual weekly meetings whilst ensuring that all necessary requirements set out by the scout association were met. We have heard many comments from grateful parents for all the challenges that were set or virtual meetings that were held which gave a 'very slight' normality to the weekly scouting evenings for many of our young people.

Quite a few Groups also took advantage of the county set challenges such as Shirehike which allowed the young people to earn hiking badges under their own steam, whilst staying in their local area. It has been great to see the collaboration between different sections within groups to help ensure that scouting was still taking place. The district has continued to issue a number of badges including top awards to the young people during this time.

Slowly The Malverns is starting to get back to a bit of normality with Groups starting to meet face to face once again and although initially the risk assessments that were needed were a little daunting, with the help of Derek Barnes, Groups were able to ensure that all covid risk areas were noted and mitigations put in place. So once again our sincere thanks go out to Derek for his help and support.

Numbers within the district have taken a significant fall of around 21%, during the past 12 months, however recent data on online scout manager is showing a steep climb since face to face scouting restarted and enquiries to join are coming in daily. We hope that we will be able to report a significant increase at next year's AGM.

Leader training has slowed during this period although the County training team have been running certain modules virtually which a few leaders have taken advantage of. Mandatory training requirements including safety and safeguarding has become a requirement for all leaders prior to starting back face to face. The number of adults within the district that are not up to date with their mandatory training has reduced but there is still some work to do to get everyone compliant and we would like to ask everyone to check their compass records to ensure that their training is up to date.

We would like to reiterate our thanks to all the leaders and helpers in the district for all the scouting they have provided over the last year. We would also like to thank all the parents who have encouraged and supported their child(ren). Lastly we would also like to thank all of the District Team for all their help in continuing to support all scouting in The Malverns.

CUB SCOUTS

2020/2021 has seen continued disruption due to COVID restrictions and lockdowns. Each Pack did their best in unprecedented circumstances and despite the difficulties posed, leaders maintained contact with their Cubs to ensure they did not feel forgotten and by the summer term all are back meeting face-to-face with their young people.

There were no District events planned, but there was a district contribution to the County led Great Egg Hunt. Many groups and individuals also took part in the County Shirehike challenge and earnt the national 'Love the Great Indoors' challenge badges.

Whilst lockdowns meant meeting face to face was not always possible, many made use of Zoom and ran virtual meetings, meanwhile others set online challenges, and many packs made use of the county Shirehike and the National 'Great Indoors' challenges. Many forthcoming events were planned and looked forward to The branch held its AGM in February and the annual report highlighted many events from a busy 2019.

The branch executive managed a meeting in June where decisions were made to cancel or postpone events and meetings planned for June/July/Aug. It was hoped to make a start back to meeting and events in September, meanwhile a weekly Newsletter for Malvern Branch was produced to keep members up to date and in touch. At a branch executive meeting in August, events (outdoor) were planed for Sept & October. In September members visited Hellens, at Much Marcle after a tour of the house we were able to enjoy tea in the gardens. October saw us on a 'Walking Quiz' finishing at the tearoom on Gt. Malvern Station. With virus infection rates rising, the branch held its first 'online' meeting in November, taking part in a Bonfire Night Quiz.
